

FORTVILLE TOWN COUNCIL MEETING

The Fortville Town Council met Monday, April 5, 2010 at 4:30 p.m. at the Town Hall. The meeting was called to order by President, SEAN SIMMONS. Those present or absent:

Council Present: SEAN SIMMONS, PHIL SCROGHAM, JEFF RATLIFF, RON STAFFORD and TAMMY GILBERT

The March 15, 2010, minutes had been distributed to Council Members prior to the meeting. A Motion was made by RON STAFFORD to approve the minutes with the word "mobile" inserted before speed sign. Second by JEFF RATLIFF; Motion carried 5-0.

Special Response Training discussion will be on the agenda April 19, 2010.

A Motion was made to pass on second reading Ordinance 2010-3A, An Ordinance Amending Chapter 70 Subsection 71.05 of the Code of Ordinances of the Town of Fortville, Indiana by PHIL SCROGHAM. Second by RON STAFFORD; Motion carried 4-1. (RATLIFF nay)

RON STAFFORD- could like clarification for the residence of Fortville on the State statute regarding golf carts on city streets and would like to see the Ordinance that GREGG MORELOCK originally drafted to compare. BEN KIPHART will get copies of both for the council.

JOE RENNER – State Road 13 was originally to be closed a couple weeks, then it changed to 4-6 months and now it will be 1 year. There will be an unofficial detour route marked on Delaware Street. The State will video the street and will make any repairs to the street from damage done by the extra traffic. No parking signs will be posted along Delaware Street.

SEAN SIMMONS- informed the council that per JODIE WOODS, attorney for IACT, the vouchers are not be signed if you vote "no" unless there is a separate motion.

RON STAFFORD – inquired as to when the landscaping on Michigan and Main Streets would be completed by the State. JOE RENNER stated the State would finish when weather permitted.

JEFF RATLIFF – damage has been done to the pavement at Leland and Stat Street by a heavy loader. JEFF RATLIFF and RON STAFFORD requested council approve to attend an IACT class in May.

A Motion was made by JEFF RATLIFF permitting him and RON STAFFORD to attend the 2 day IACT class on May 18th and 19th. Second by RON STAFFORD; motion denied 2-3 (STAFFORD,RATLIFF-yea)(GILBERT, SCROGHAM, SIMMONS-nay)

CALVIN HENDRIX-PARKER- suggested the council submit a written report regarding the information obtained at continuing education classes.

A Motion was made by PHIL SCROGHAM to approve the vouchers. Second by TAMMY GILBERT; Motion carried 3-2. (RATLIFF, STAFFORD-nay) JEFF RATLIFF was still reviewing the vouchers when this Motion was made.
