

FORTVILLE TOWN COUNCIL MEETING

The Fortville Town Council met Monday, May 3, 2010 at 4:30 p.m. at the Town Hall. The meeting was called to order by President, SEAN SIMMONS. Those present or absent:

Council Present: SEAN SIMMONS, PHIL SCROGHAM, JEFF RATLIFF, RON STAFFORD and TAMMY GILBERT

The April 19, 2010, minutes had been distributed to Council Members prior to the meeting. A Motion was made by RON STAFFORD to approve the minutes. Second by PHIL SCROGHAM; Motion carried 4-0.

After council discussion and no one from the public to speak a Motion was made to pass on first reading Ordinance 2010-5A, An Ordinance Regarding the Operation of Non-Traditional Vehicles on the Public Ways of the Town of Fortville, Indiana by PHIL SCROGHAM. Second by TAMMY GILBERT; Motion carried 4-1. (STAFFORD-nay)

MIKE DALE – Hancock Planning Commission asked for direction from the council and the council agreed to have MIKE DALE make the suggested changes and have ready for the meeting on May 17, 2010, so the Comprehensive Plan can be on the June agenda at the Planning Commission. A flow chart was given to the council to give a better understanding of the Planning Commission process.

A Motion was made by PHIL SCROGHAM to give MIKE DALE the authority to incorporate GREGG MORELOCK and DENNIS MALOYS' comments into the Comprehensive Plan. Second by JEFF RATLIFF; Motion carried 5-0.

JOE RENNER- Town Manager

1. Informed council that a resident has asked to place a double at 625 S. Oak Street.
2. An invoice for police vehicle equipment from Waymire for \$5885.40 will be coming;
3. The lift station in Timber Ridge has had numerous repairs totaling \$13,387.00. To substantially reduce our repair cost we can upgrade to 3 phase pumps for approximately \$14,000.00.

A Motion was made to upgrade the lift station in Timber Ridge by PHIL SCROGHAM. Second by RON STAFFORD; Motion carried 5-0.

4. The Town received a Certificate of Recognition for Stormwater Phase II. Only 7 MS4 communities out of 155 received this certificate for completing the Phase II portion of the Stormwater. TAMMY GILBERT and all the street guys deserve the credit for this Certificate.

GREGG MORELOCK – requested an executive session on May 17, 2010, at 6:00p.m. regarding personnel matters. A Motion was made by PHIL SCROGHAM to set an Executive Session for May 17, 2010, at 6:00 p.m. Second by RON STAFFORD; Motion carried 5-0.

PHIL SCROGHAM- stated that EDDIE GROSS has complained about his water bill and wants the Town to give him a reduction on the bill.

A Motion was made by PHIL SCROGHAM to approve the vouchers. Second by RON STAFFORD; Motion carried 3-2. (RATLIFF, SIMMONS-nay)
