Town Council Meeting

Opening of Meeting:

The meeting was held at Fortville Municipal Building at 714 East Broadway, Fortville, IN. Meeting was called to order by Council President Robert Holland at 7:02pm.

Approval of Minutes:

Tim Hexamer made the motion to approve June 19, 2017 minutes, Robert Holland seconded the motion. Motion did not carry due to Michael Frischkorn being absent at the June 19 meeting. This will be addressed at the July 17th council meeting.

New Business:

- a. RDC Update – Burns Gutzweiller stated that the South Madison Master Plan is on track and the 2nd reading of the ordinance will be tonight. He said Broadway would be ready in August. Burns also mentioned his last RDC Meeting will be the July 20th meeting. Robert Holland thanked Burns for his time.
- b. FAI Event Request – Dave Beatson asked for approval of the September 9th Cruise In. He is asking for a few barricades to be in put up this Friday for Music on Main also. Michael Frischkorn made the motion to approve the Cruise In on September 9th with the rain date being September 10th. Tim Hexamer seconded the motion. Motion carried, passed 3-0.
- c. Planning Commission Appointment – Lacey Willard expressed interest in the plan commission seat. Tim Hexamer made the motion to approve Lacey for the plan commission seat effective July 11, 2017, with Michael Frischkorn seconding the motion. Motion carried, passed 3-0.

- d. Matching Funds Commitment – Joe Renner stated that we need to move forward with the PILOT Program and bond to have the funds available. Beth Marsh stated that we will use various capital funds and storm water. Michael Frischkorn made a motion to approve the Community Crossing Project with Tim Hexamer seconding the motion. Motion carried, passed 3-0. Michael Frischkorn also made a motion to approve Joe Renner to sign off on the applications for the Community Crossing Project. Tim Hexamer seconded the motion. Motion carried, passed 3-0.
